Health and Wellness Center

The Health and Welfare Fund Board of Trustees are turning the plans of the new Health and Wellness Center into reality. They have signed an agreement with Cerner Health to provide medical care at the facility.

Co-Chair James Coyne wants to convey to all members the importance of staying healthy. Being proactive with annual physicals can provide doctors with an early diagnosis of predetermined conditions, and support you when various types of treatments are required. This annual physical will keep you healthier in your career and into retirement. A medical doctor will be on site, along with their staff to provide comprehensive care, including necessary treatment plans such as prescriptions, blood work, referrals for diagnostic testing and/or specialty care physicians, etc. There will be a Motion Health program on site (including physical therapy) to assist members with the diagnosis and treatment of ailments commonly experienced in the plumbing trades.

David Ariano, Co-Chair stated, "The trustees of your Health and Welfare plan are excited to be well on our way to opening the first Health and Wellness center for the plumbers and their families. This center will provide care on a much more personal level than you could receive through the regular healthcare industry. Unlike the traditional medical model which is focused on maximizing the number of bodies moved through their office every day, our facility is focused on providing the highest level of care to our members. It has taken your trustees an enormous amount of time and effort to find the right location, build out a space, and hire the right professionals to ensure our members receive the highest level of care. This is a medical facility designed by our members and member contractors for our members/employees and their families. We will keep you posted on our progress."

General Office Information

Summer is over and fall is in the air. I would like to take this opportunity to tell you about some changes in the General Office.

The Local 130 website, www.ualocal130.org, is getting a makeover. Changes to our website's Home Page will be in place soon (approximately mid-October) and navigation will become easier. Coming soon, the "In Memoriam" page will contain funeral service information that we may have on recently deceased members. In the "Members Only" section, we have already implemented a couple of changes:

- Members Notices: Letters already sent to the members are uploaded here.
- **Signatory Contractors:** Lists all signatory contractors with a search option.

To access the Members Only Section, click on "*Member Login*" in the upper left corner of the Home Page. Check our website often for current news and activities.

Please be sure to carry your Local 130 I.D. card on you at all jobsites. Business Agents are now able to:

- Scan your card to help insure you have a current referral to your contractor.
- Check your certifications and confirm that you are current on your 4-hour Continuing Education and your plumbing license.
- Verify your current dues status. This will be helpful for those working in a building that needs to verify current membership. (Dues stamps have been omitted on the U.A. membership card).

If you do not have a Local 130 I.D. card, please stop in any of our offices to request one. Our Chicago office can print it on the spot. The remote offices will check to see that your picture is current and request that the Chicago office print and mail a new card to the address on file. It is a good time to verify that your address, phone number, certs, and plumbing license information is up to date.

Also as a reminder, if you take continuing education classes any place other than at a Local 130 site, you need to give that information to the Union Office so your records are accurate.


